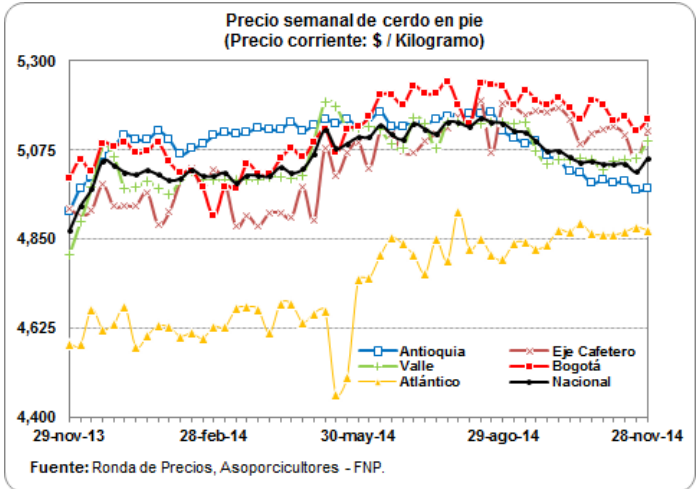

**Nota importante:** Este es un sondeo de precios telefónico a una muestra o grupo de porcicultores y comercializadores de cada zona: Antioquia, Eje Cafetero, Valle del Cauca, Atlántico y Bogotá, que permite obtener una aproximación del precio promedio nacional, pero que de ninguna manera representa tamaño del mercado o el universo de productores y comercializadores de cerdo en nuestro país. En este sentido este ejercicio busca ser un referente de las transacciones en valor y volumen de cerdos sacrificados en planta, de buena genética, entre 90 y 120 kg. dentro de los mercados de cerdos cebados y canales de estas zonas. En particular, el diseño de la publicación se orienta a resaltar los límites máximos, medios y mínimos de los precios promedio, dando un posible margen de variación del precio en cada región, lo que no desconoce que se den transacciones en el mercado con un valor mayor o menor a la ronda. Por último, queremos enfatizar que esta ronda busca ser un referente de los precios y no se orienta a determinar el precio del mercado.

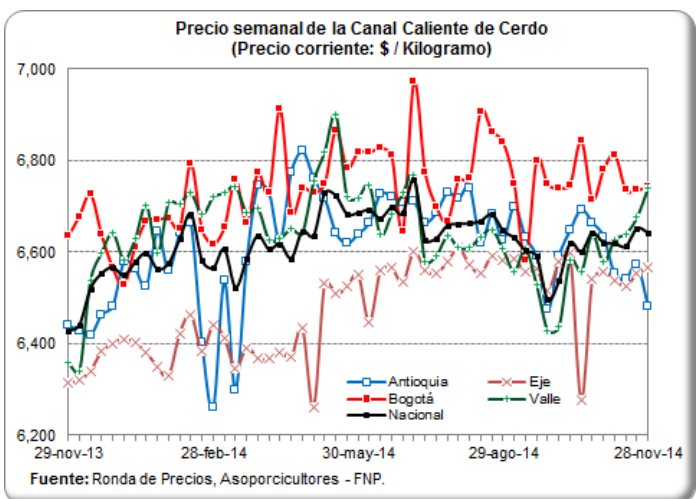
